In line with the changes as part of the new ALN and ET (Wales) Act we will continue to develop our person centered approaches to annual reviews.

At annual reviews we will ensure pupils' needs and views are at the heart of our decision making processes.

In particular we will be asking 4 key questions:

- What's important to?
- What's important for?
- What's working?
- What's not working/how can we make things even better?

Additional Learning Needs (ALN)

The way in which pupils' special educational needs (SEN) will be:

identified, **assessed** and **met** in Wales is changing.

The Additional Learning Needs and Education Tribunal (Wales) Act

The Act is expected to come into force from **September 2020** and the implementation period will last until 2023.

What are the key changes?

- The term "Additional Learning Needs" (ALN) will replace "Special Educational Needs" (SEN).
- The new system will cover the age group 0-25 years.
- Statements of SEN will be replaced with an Individual Development Plan (IDP).
- Local authorities will have the duty for preparing and implementing an IDP.
- Increased pupil involvement.
- There will be a new ALN Code of Practice.
- There will be a right to appeal to the ALN Tribunal.

What will the new system do?

The new system will:

- ensure all learners with ALN are supported to overcome barriers to learning and can achieve their full potential;
- improve the planning and delivery of support for learners from 0 to 25 with ALN, placing learners' needs, views, wishes and feelings at the heart of the process;
- focus on the importance of identifying needs early and putting in place timely and effective interventions which are monitored and adapted to ensure they deliver the right outcomes.



Parent partnerships

We highly value our partnership working with all parents/carers. To make the changes that are needed we will be working very closely with parents, carers and of course our pupils.

The Act requires that learners' views should always be considered as part of the planning process, along with those of their parents.

It is important that our pupils see the planning process as something which is done with them rather than to them.

What will be in a IDP?

To be effective an IDP will include:

- Pupils' identified needs.
- Agreed outcomes for the pupil.
- Additional provision to meet those needs.
- An Action Plan that sets out:
 - ⇒ How?
 - ⇒ When?
 - ⇒ Who will deliver the agreed interventions and how they will be measured.
- Information in the action plan will need to be robust to form a legally enforceable document.
- Success criteria and review dates.
